The Detailed Action Plan of Priority Activities of WG in 2020

1. Background

The National Waste Management and Pollution Control Strategy (NWMPCS) 2016-2020 has the following vision and overall goal. The implementation plan of NWMPCS 2016-2020 identifies 35 targets and 48 activities under 7 thematic areas.

Vision: A clean healthy environment leads to productive sustainable development. Therefore our vision is *"towards clean sustainable environment"*. Overall Goal: An environmentally sustainable Vanuatu, in which all types of wastes generated are reduced, collected, reused, recycled and treated by environmentally sound technologies suited to local conditions and waste going to landfill is minimized to the lowest possible amount.

DEPC and J-PRISM II discussed and set a project output as *"Institutional capacity of DEPC to implement NWMPCS is enhanced with the cooperation of the Working Group*" at the 1st Joint Coordinating Committee (JCC) meeting in February 2018. To realize the output, DEPC took the initiative and Working Group (WG) was formulated in June 2018 to study and review the implementation plan of NWMPCS. WG consists of i) fieldwork, ii) discussion and iii) monitoring/reporting in accordance with the seven thematic area of NWMPCS. The initial members of WG were the Department of Environmental Protection and Conservation (DEPC), Port Vila City Council (PVCC) and Luganville Municipal Council (LMC). The concept note of WG was agreed in May 2018 and WG was officially launched in June 2018. Priority activities of WG in 2019 were agreed at the 2nd JCC meeting in October 2018 as follows:

[Priority activities in 2019]

- i. Promotion of the planning standard on SWM, and penetration of framework of SWM plan into provincial and municipal government council (Thematic 1)
- ii. Pre-feasibility study of a Container Deposit Scheme (CDS) to support the polluter pays principle (Thematic 2)
- iii. Discussion of option of waste minimization to reflect to the NWMPCS (Thematic 4)
- iv. Coordination to develop awareness materials based on the experience in LMC and discussion on dissemination to relevant stakeholders with Ministry of Education. (Thematic 7)

WG discussed and approved the priority activities, which will be implemented in 2020, based on the monitoring result of NWMPCS at the 3rd JCC meeting on 24th February 2020. In









addition, NWMPCS 2016-2020 has to be renewed for another 5 years. WG will be a main body of stakeholders' consultation for overall evaluation of NWMPCS in the final year 2020 which will be reflected in the next term of NWMPCS. This detailed action plan describes the responsibility of each action, implementation schedule and budget amount for the priority activities.

2. Monitoring result of progress of NWMPCS in 2019

NWMPCS was started in 2016 and monitored by DEPC regularly in November 2017, October 2018 and September 2019. There are several progress achieved in 2019. Especially the significant progress of 2019 was the endorsement of the second phase of single-use plastic ban and the Council of Ministers (COM) decision for introducing Container Deposit Scheme (CDS) in principle was made. The draft Vanuatu National Plastic Strategy was developed. Achievement of each thematic area in 2019 is summarized below.

Thematic Area 1 - Policy, Legislation and Enforcement

- The COM has endorsed the second phase of the ban on single-use plastic items in Vanuatu, which is effective from 1st December 2019. A Vanuatu National Plastic Strategy 2020-2030 and its implementation plan 2020-2025 were drafted.
- A SWM planning form was drafted for annual monitoring of SWM in provinces and municipals in line with the Waste Management Act No.24 of 2014. Existing SWM plans were reviewed and the form is simplified in consideration of the capacity of SWM planning in provincial and municipal governments. The form was approved by the DEPC director and distributed through the Department of Local Authorities (DLA) in November 2019.
- Licensing system for Private Waste Operators (PWO) started in 2018 and 11 companies and organizations register the license as of September 2019. However, only 2 companies and organizations submitted an annual report, although the annual report is mandatory to be submitted for renewal of the license annually, and majority of PWO licenses were not renewed as per the agreed renewal date as stated in the Licenses. Enforcement of the regulation should be strengthened thoroughly next year.
- A draft landfill guideline has been developed but not yet endorsed. It is required to accelerate the approval process of the guideline to obey the new proposal of landfill site to fit the conditions under EIA process after 2020.
- A workshop of the Disaster Waste Management (DWM) was held in November 2019 supported by J-PRISM II, SPREP and Canada und for Local Initiatives (CFLI). The regional DWM guideline is in progress. The second workshop of DWM was held in March 2020. Based on the training, a national DWM guideline will be developed in 2020.

Thematic Area 2 - Sustainable Financing

• Pre-feasibility study for introducing CDS was conducted in March 2019. The study proposed a Managing Agency (MA) model to sustain the CDS in Vanuatu in consideration of









local beverage producers, and concluded that Vanuatu had a potential to introduce CDS.

- Introduction of CDS with the Managing Agency (MA) model in principle was proposed to the COM, to request funding from donors to develop the detailed design of the scheme and to convene a working group to this end, and approved on 30th October 2019.
- Base on the COM decision, a CDS technical working group was established in December 2019. The detailed design planning is on-going to realize CDS in Vanuatu harmonized with the results of stakeholders' consultation through the WG. Launch of the CDS is aimed at the year of 2021.

Thematic Area 3 - Capacity Development

• There is little achievement in this thematic area in 2019.

Thematic 4 - Waste Minimization

• Framework of a waste minimization plan was developed based on a discussion of WG to identify the feasible options for waste minimization in Vanuatu. The waste minimization plan will be developed and endorsed after stakeholders' consultation in 2020.

Thematic 5 - Integrated Waste Management

- Waste collection service is provided in Port Vila, Luganville, Lenakel, Shefa, Sanma and Malampa. Torba, Penama and Tafea will be consulted in 2020.
- Recycle Corp is the only recycle company who has a license of PWO with approved treatment and storage facility in Port Vila and Luganville.
- EIA for a new dumping site in Lenakel Municipal Council and Tafea Province was implemented. DEPC is seeking a financial support for construction of landfill site. LMC submitted a proposal to extend and improve a current dumping site into a sanitary landfill site for the Asian Development Bank (ADB) as a part of Luganville Urban Development Project.
- There is no significant achievement in this thematic area in 2019.

Thematic 6 - National Coordination

• There is no achievement in this thematic area in 2019.

Thematic Area 7 - Public Awareness

• Public awareness to councils, schools and communities was carried out at 45% of provinces and municipalities by the DEPC.

Summary of monitoring results of the NWMPCS are shown in the table below. Achievement of the NWMPCS reaches 38% in 2019. Four priority activities contributed progress in each









thematic area. By contrast, progress of thematic area 5 and 6 is slow relatively. This tendency will continue in 2020. On a projection basis, no thematic area could achieve 100% in the target year 2020. Expected achievement in 2020 would be 58%, which could be accelerated to achieve the goal in a year or should be followed in the next term of NWMPCS. The details of monitoring results are shown in Attachment-1.

- i. Dissemination of annual SWM planning and monitoring system in provincial and municipal government councils (Thematic 1, NWMPCS).
- ii. Detailed design of a Container Deposit Scheme (CDS) for its initial setup (Thematic 2, NWMPCS)
- iii. Development and endorsement of a waste minimization plan (Thematic 4, NWMPCS)
- *iv.* Promotion of Clean School Programme by identifying one school in each province as an environment model school and environment ambassador (Thematic 7, NWMPCS)
- 4. Action Plan

NWMPCS Working Group Management Plan in 2020

NWMPCS Working Group (WG) is regularly held from 2018. In 2020, WG is scheduled to be held three (3) times, especially aiming to develop the NWMPCS 2021-2025. Stakeholders of SWM will be involved in the process of reviewing the monitoring results of the NWMPCS 2016-2020 and developing the new strategy. Tentative schedule, agenda and expected participants are shown below. The schedule could be modified according to the progress of activities.

Result of priority activity in 2019

- A pre-feasibility study for introducing CDS was implemented in March 2020, and based on the study results, on Wednesday 30th October 2019 the COM made the following decisions: 1) the COM approves the introduction of a Container Deposit Scheme (CDS) that uses a Managing Agency model; 2) the COM approves that under a Management Agency model, the CDS will be solely managed by the management agent under the supervision of a board appointed by the Minister responsible for environment; 3) the COM approves the formation of a working group to develop the detailed design of the CDS under overall direction of the DEPC; 4) the COM approves the review of legislation necessary to implement the CDS; and 5) the COM approves the DEPC seeks funding donor partners for the detailed design of the CDS including JICA.
- Based on the COM decision, a CDS technical working group composed of the representatives of the national governments, beverage producers and importers, and civil society was formed, to develop the detailed design for the CDS, in December of 2019.
- On 24th February 2020, the 3rd Joint Coordinating Committee of J-PRISM II agreed that a new output "Economic incentive scheme is initiated for promotion of 3R + Return in Vanuatu" be added to introduce the CDS in Vanuatu.











Work Schedule

Feasibility study for introducing CDS in Vanuatu will be implemented in 2020 supported by JICA through J-PRISM II.

Vanuatu National Action Plan to reduce releases of Unintentional Persistent Organic Pollutants (uPOPs) (2018-2022)

Persistent Organic Pollutants (POPs) are toxic chemicals that can travel long distances through air and water and accumulate in the fatty tissues of humans and other animals. These POPs do not degrade quickly over time, and consequently, potentially expose people to serious health issues including cancer, birth defects and immune system impairments. One of the Key Result Areas (KRA) for the uPOPs Action Plan is strongly related to SWM that "KRA3: Increase adoption of best practices in the waste management sector." A waste minimization plan will be developed in collaboration with uPOPs.

KRA3: Increase adoption of best practices in the waste management sector

Based on the results of the uPOPs inventory, the waste management sector is Vanuatu's main source of uPOPs emissions. While waste management practices are gradually improving with the implementation of recent donor-funded projects, there is still room for further improvement. For example, open burning of backyard waste still occurs, and there is limited understanding of the application of BAT/BEP to the waste sector. Future donor-funded projects will help to address some of these issues. Reductions in uPOPs emissions can be achieved through greater implementation of BAT and BEP measures. The specific activities to encourage adoption of best practices are as follows:

3.1 Implement a 5-year national composting campaign. This activity will contribute to achieving the NWMPCS goal of composting 60% of segregated organic wastes by 2020. This activity recognises that a sustained long-term effort is required to cause meaningful behaviour change. The composting campaign should seek to: raise awareness of composting as an









alternative to open burning and its link to reducing uPOPs production; promote practical forms of composting (e.g. backyard, community, and worm farm composting); and involve all stakeholders (e.g. through local competitions to design posters and compost bins, and public recognition for individuals and communities consistently engaging in good practices, demonstration of good techniques).

3.2 Implement at least one composting project in each province annually. This activity is realistic and achievable. Projects that could be implemented include market waste composting, community-based composting, introducing composting to selected schools, and establishment of worm farm composting.

School Environmental Education

The school environmental education guidebook was published in 2017. The book was written by Kamewa school teachers and Chairman of the Luganville Municipal Waste Management, who had previously attended JICA training on Solid Waste Management in Shibushi, Japan. The book describes the importance of waste separation and composting, aiming to educate the younger generation on waste management and to bring about changes in the long run in communities and society in the future.

Currently, the guidebook is used only in Luganville and it is expected to be utilized nationally with support of the Ministry of Education and Training (MOET). MOET requested to develop a supporting manual describing a model class to explain the role of the guidebook in accordance with the official syllabus.

Work Schedule

WG will coordinate DEPC, LMC, MOET and relevant stakeholders related to environmental education, to develop awareness materials based on the experience of school environmental education in LMC, and clarify the process of dissemination through MOET.
